



## **Zedcor Energy Inc. Announces Stock Option Grant**

CALGARY, ALBERTA – March 28, 2019: Zedcor Energy Inc. (the "Company" or "Zedcor") (TSX VENTURE: ZDC) announced that a total of 700,000 options to purchase common shares of the Company were granted to certain officers and employees of the Company, with an exercise price of \$0.15 per share. All of the options will vest as to one third thereof on each of the first, second and third anniversaries of the date of grant.
